- » **Check In Time:** From 8am
 - » Note that special arrangements can be made if necessary. Children are welcome, but needs to be **supervised at all times**.
 - » Use of all facilities, including but not limited to dams, shuttle service, etc. is at your **OWN RISK**
 - » Note that we make use of **Septic Tanks** Please, therefore do not dispose of sanitary towels or foreign objects in the toilets
 - » **Right of Admiassion RESERVED**
 - » This is a water saving environment.
 - » The speed limit is **20km** per hour on the premises.
 - » **DO NOT LITTER**
 - » Be aware that there are monkeys around and that they could steal your food and/or possessions.
 - » Do not feed ANY animals encountered on the farm.
 - » Be aware that we have wildlife in the enclosed camps on both sides of the fence.
 - » Be careful when you are in the veld as there could be bushpig, leopards, scorpions, snakes etc. which could pose a danger to you and your party.
 - » **FAUNA & FLORA or any parts there of NOT TO BE REMOVED**
- » **Check Out Time:** Sunday after the show - unless you are staying on longer
 - » **ENTER at OWN RISK**
 - » Respect the property
 - » There is an additional cost for breakages
 - » **NO DRIVING IN CAMP after 10pm**
 - » Picking of fruit is a criminal offense, prosecution will follow
